Applicable for individual applying for CIMB Preferred membership with a deposit balance exceeding THB 3 million within the month of applying for CIMB Preferred</li><li>3. The Bank shall calculate net deposit interest at the standard rate at the end of each day and shall begin applying the interest rate inclusive of the bonus from the 8th day of the following month, for a duration of four months. From 8 January 2026 onward, receive the normal interest rate.</li><li>c) Accounts opened or the conditions met between 1 – 30 September 2025: Receive the interest rate including the bonus rate from 8 October 2025 to 7 February 2026. <b>Key Requirements</b> 	<ul style="list-style-type: none"> <li>Account Opening Channels for Speed D Plus Savings by CIMB Thai ("Speed D+")               <ol style="list-style-type: none"> <li>CIMB THAI Application, for individuals with Thai nationality only. <sup>(1)</sup></li> <li>Branches, for Thai individuals, and foreign customer.</li> <li>TrueMoney application, for individuals with Thai nationality, to be used as a beneficiary account. <sup>(2)</sup></li> </ol> <p><sup>(1)</sup>In case of Speed D+ account opening via CIMB THAI Application, the branch owner will be Langsuan Branch.</p> <p><sup>(2)</sup>In case that a customer opens a Speed D+ savings account via TrueMoney application, the home branch shall be specified as Head Office, Langsuan Road Branch. Eligibility is reserved for customers who are at least 20 years old on the date of account opening.</p> </li> <li>Customer must be aged 15 years old and above at the account opening date.</li> <li>Customer must have a valid email address and apply for CIMB THAI Application to do financial transactions through the account.</li> <li>Customer can open only 1 account of Speed D+.</li> <li>Only single account is eligible for Speed D+ account opening.</li> <li>Speed D+ account is no passbook savings accounts. <b>Deposit/Withdrawal/ Transfer and Other Benefits and Conditions</b> 	<ul style="list-style-type: none"> <li>Deposit/ Withdrawal via branch or any other channels as specified by the Bank.</li> <li>Funds transfer or payment via CIMB THAI Application or any other channels as specified by the Bank.</li> <li>Require additional identity verification via facial recognition, and any other identity verification measures the bank may specify.</li> <li>In case of no account movement (dormant status), please contact CIMB Thai branch or any other channels as specified by the Bank to reactivate the account before conducting any transactions such as deposit, withdrawal, money transfer or payment.</li> <li><b>In case of deposit account opening, if no deposit is made within the date falling 30 days after the account opening date, such deposit account will be closed automatically without prior or further notice.</b></li> <li>From 11 August 2021 onwards, the deposit shall receive protection by Deposit Protection Agency, as prescribed by law, in the amount of THB 1 million per 1 depositor per 1 financial institution.</li> </ul>
<b>Account Maintenance Fee</b> 	<p>In case where the account has remaining balance less than THB 2,000 with no movement or has been uncontactable for over one year (consecutive 12 months), an account maintenance fee will be charged at THB 50 per month.</p>
